THE ELECTORAL COUNT REFORM ACT OF 2022

PRESENTED BY SHARON GURAK AND ANN MAU

Sharon Gurak, a longtime branch member and an attorney, and Ann Mau, a Phoenixville attorney, have both attended an informational meeting on this 2022 legislation. In response to the events of January 6, 2021 and the attempts to alter Congressional certification of the 2020 election, Congress enacted legislation to address many of the issues that arose on that day. Join us to discuss the improvements, gaps and prospects of the Electoral Count Reform Act (ECRA) and explore how recent law would govern scenarios of dueling slates of electors, a state that fails to certify that it is a presidential vote and a Twelfth Amendment contested election process. With another presidential election coming up in November, it is important to know how this legislation will work to protect our voting process. There will be time for discussion and questions.

Do bring guests on the 14th; it should be a very interesting meeting.

FROM OUR PRESIDENT

Welcome back AAUW members! I hope you had a wonderful summer with some rest, relaxation and renewal, because this is going to be a very active Autumn!

Our national organization has partnered with <u>When We All Vote</u>, a leading nationwide nonpartisan initiative to change the culture around voting and increase participation across race and age. When We All Vote was started by Michelle Obama about six years ago. Amanda Hollowell, the Managing Director, noted in a webinar on July 31st that in 2020 there were 65% of the population or 80 million people in the US who did not vote. Isn't that shocking? AAUW has a long tradition of GOTV (Get Out the Vote) events. The current campaign is called It's My Vote. Stay tuned for more information about our local voting efforts. On August 15th our AAUW-PA organization had a webinar about the new Title 9 regulations. The regulations cover sex discrimination and conduct based on sex stereotypes, sex characteristics, pregnancy and related conditions, sexual orientation and gender identity. New regulations went into effect August 1st. Twenty-six states are challenging the regulations. PA is not one. You can watch this webinar on <u>aauw.org.</u>

A focus of the lawsuits is sexual identity and orientation. Kansas is the dominant state in terms of the
